

- 3. Guidance on Measuring Organizational Efficiency at State Departments of Transportation (OM) 24 months; \$400K
- Aligning Relationships Between Transportation Asset Management, Planning, and Programming Inclusive of Emerging Objectives of Mobility and Climate Resilience (AM) – 36 months; \$400K
- 5. Create a Performance Management "Blue Book" (CC) 24 months; \$800K

- Mission The focus of the Subcommittee on Organizational Management is on the development and implementation of:

 - Measures
 - Improvement frameworks
 - Strategies
 - ...in order to optimize the efficiency and effectiveness of transportation agencies
- We employ this definition of "Organizational Management" the process of organizing, planning, leading and optimizing resources within an agency with the overall aim of achieving its goals and objectives.
- The concept of organizational management is based on the idea that there is a correlation between an agency's capabilities in people, operations. and agency strategies to successfully implement their goals and objectives.



- OM Subcommittee will be working with key executives at AASHTO member organizations to recruit members for the Committee
- OM will be developing and delivering "micro-topic" webinars in areas areas related to organizational management

- Working on continued partnership building:

 - OM has been working with AJE15 to determine possible areas of mutual interest, potentially leading to areas of possible joint work.

Background & Purpose

- Transportation agency goals and objectives are focusing on broad societal goals spanning across sectors. This has created a need to consider impacts and performance in a range of dimensions that have not been the traditional focus.
- The Task Force works to improve how State DOTs conduct performance management by identifying emerging performing areas, making recommendations for research, and creates a platform for knowledge exchange.
- Areas of interest include multimodal accessibility/destination access, equity, resilience, climate change impacts, health, etc.



- Task force is currently focusing on Equity/Affordability
- Plans to expand as time and membership allows
 - Accessibility/multimodal mobility
 - Climate/GHG and carbon reduction
 - Equity/Affordability



Emerging Performance Areas – Current Activities

- Received positive feedback on featuring guest speakers at task force meetings
- November 2024 meeting featured three MnDOT speakers with an overview and highlights on the Advancing Transportation Equity Initiative (Hally Turner, Kadence Kushnir, and Erika Shepard)
- December 2024 meeting presentation topic was on Social Science at DOTs, with presentations from Nellie Moore from DDOT, and Kristopher Carter from MassDOT.
- Early 2025 meeting will be a debrief of TRB and the "TPM for Equity Progress" workshop in St. Louis conference in September.
